PURPOSES OF TRANSFERRING YOUR PERSONAL DATA TO ABROAD

Your foregoing personal data might be transferred for the following purposes and reasons.

- Your personal data will be transferred to our contracted domestic and foreign service providers for sending you mass e-mails and text messages if you wish to be informed about our campaigns and promotions.
- Your personal data collected in accordance with the Cookie Policy and website user activity data (items clicked, duration of visits etc.) that are collected for offering better services to you and other members and customers will be transferred to the companies that analyze such data and provide methods of business development.
- We might transfer your personal data to companies working with us for sales, marketing and reporting activities, such as Hype, Google Analytics etc.
- The servers of our e-mail service provider are on abroad and therefore your personal data included in our e-mails are considered as transferred to abroad when sending internal and external e-mails.
